**WAFER SUPPLY AGREEMENT**

This announcement is made by Comtec Solar Systems Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis.

**THE WAFER SUPPLY AGREEMENT**

The board (“**Board**”) of directors (“**Directors**”) of the Company is pleased to announce that on 27 December 2013, Comtec Solar (Hong Kong) Limited (“**Comtec HK**”), a company incorporated in Hong Kong and a wholly-owned subsidiary of the Company, entered into a wafer supply agreement (the “**Wafer Supply Agreement**”) with Mission Solar Energy LLC, a Delaware limited liability company (“**Mission**”), pursuant to which Comtec HK will supply 156mm × 156mm N-type mono crystalline silicon wafers representing approximately 500MW for use in solar cells (the “**Mono Wafers**”) to Mission from June 2014 to July 2017. Pursuant to the Wafer Supply Agreement, Mission is required to take delivery of, and Comtec HK is required to deliver, a certain amount of Mono Wafers every month from June 2014 to July 2017 in accordance to the delivery schedule set out in the Wafer Supply Agreement.

**REASONS FOR AND BENEFITS OF THE WAFER SUPPLY AGREEMENT**

The Directors believe the Wafer Supply Agreement will enable the Group to further strengthen and diversify its customer base as well as to gain further business opportunities in respect of the N-type mono crystalline silicon wafer products of the Group. The Wafer Supply Agreement also serves to demonstrate the competitive advantages of the Group in production technologies and product qualities in the solar industry and its leading position in the high efficiency N-type solar wafer market.

Mission is a company incorporated in the state of Delaware, the United States of America primarily engaged in the business of manufacturing high efficiency solar cell and panels.
