Comtec Solar to present at RBS China Access, Macquarie Alternative Energy Conferences next month

- **US, European investors seeking more meetings**
- **Extra 400 MW capacity expansion eyes year-end completion**

Hong Kong, November 25, 2010 – Comtec Solar Systems Group Limited (“Comtec” or the “Company”, together with its subsidiaries the “Group”, stock code: HK: 712), a PRC-based leading manufacturer of monocrystalline solar wafers, will present at the RBS China Access – 12th Five-Year Plan Conference in Hong Kong, and at the Macquarie Alternative Energy Conference 2010 in London and New York, respectively.

On December 2 & 3, Mr. Keith Chau, CFO of Comtec, will present at the conference hosted by RBS, which will focus on investment benefits from Chinese companies. One-on-one meetings will take place at the Conrad Hotel Hong Kong.

Following the RBS conference, Mr. Keith Chau will head to London and New York to participate in the Macquarie Alternative Energy Conference which will be held on December 7, and December 8 & 9, respectively. Attending companies are in the solar and wind power industries and are closely followed by institutional investors in Europe and the US.

“We recently received lots of inquiries from European and US investors trying to outflow capital to the China market. Many of them have already put Comtec on their radar screens and plan to visit our Shanghai factory. Due to the great deal of interest from these potential investors and the invitations from well-known I-bankers, we will continue to participate in these types of conferences.

Our capacity expansion plan is on schedule and the extra 400MW facilities will be completed by the end of 2010. After the completion of this extra capacity, we will have 600MW total production capacity which is triple our 2010 capacity,” said Comtec Chairman and CEO Mr. John Zhang.
