- **New supply framework agreement for up to 120MW**
- **2011 signed orders already reach 128% of 2010 year end capacity**

Hong Kong, October 4, 2010 – Comtec Solar Systems Group Limited ("Comtec" or the "Company", together with its subsidiaries the "Group", stock code: HK: 712) a PRC-based leading manufacturer of monocrystalline solar wafers, is pleased to announce the Group has signed a new wafer supply framework agreement with price subject to negotiation to provide **Dongfang Electric Corporation (Yixing) Maiji Solar Technology Company Limited ("Dongfang")**, a subsidiary of **Dongfang Electric Corporation Limited** (HK: 1072; SHA: 600875), with a total of up to 120MW in monocrystalline solar wafers.

Under the terms of the contract, Comtec will supply Dongfang with up to 120MW of monocrystalline wafers from January 2011 to December 2011.
