Comtec Solar signed another wafer supply agreements in approximately 350MW with major customers

- Already filled up 450MW on production capacity for 2011
- Expect more supply agreements will sign up in the coming future

Hong Kong, 2 September 2010 – Comtec Solar Systems Group Limited ("Comtec" or the "Company", together with its subsidiaries the "Group", stock code: 712) a PRC-based leading manufacturer of monocrystalline solar wafers, is pleased to announce the Group has signed another wafer supply agreements to provide major customers, JA Solar Holdings Co. Ltd. ("JA Solar"), Suntech Power Holdings Co. Ltd. ("Suntech"), and Canadian Solar Inc. ("Canadian Solar"), with the total of approximately 350MW in monocrystalline solar wafers.

The Group signed wafer supply agreements with JA Solar, Suntech and Canadian Solar. Under the terms of the contracts, Comtec will supply JA Solar, Suntech and Canadian Solar with approximately 150MW, 150MW and 50MW of monocrystalline wafers respectively from January 2011 to December 2011.

"Together with the last agreement with China Sunergy, we presently have total of 450MW wafer supply agreements on hand with our major customers for 2011. Although our customers keep requesting us to sign more supply agreements, we will do the best to allocate our limited capacities to each customers in the fair manner. I believe that we will keep signing up more agreements in the coming period. Meanwhile, we will push the progress of additional 400MW expansion so that we can have 1GW capacity next year to satisfy the high demands from our customers."
